- 5. WEIGH-IN

The official weigh-in must be organised on the evenings before the competition

Unofficial weigh-in: 18:00h – 19:00h

Official weigh-in: 19:00h – 19:30h

- Draw

Round 1 - Evening before the competition on 25 June 2010 at 20:00 (numbers will be drawn to decide order of contests)

E/SE Region tournament - first contest will be held between the 2 teams of RUS, then continue according to draw. Draw will be held by EJU referees.

Round 3 - Evening before the competition on 24 September at 20:00 (numbers will be drawn to decide order of contests). Draw will be held by EJU delegate or EJU referees.

EJU dress code for coaches is obligatory for all draw meetings.



# European Championships for Clubs - Men

## RULES 2010

### **1. ENTRIES**

Starting in 2010 the European Judo Union offers a new system of European Championships for Clubs (ECC) for men, divided in 3 regions (in total 6 regions), for developing this event in all regions of the continent, and also changing the number of weight categories from 7 to 5 for increasing the number of teams. The main reason for all changes is to give small countries and clubs the possibility to take part on this very popular event. Also the inscription fee is reduced to **1.500 euro**.

Each EJU Member Federation which has an official qualification system (one day national championship minimum or league system championship) can enter the teams who are the medallist of the last finished championship (before the deadline of ECC inscription). The medallist from the last ECC for men are direct qualified to the third round. If they are also medallist of the last national team championship, their federations can use the place/places for other teams.

Entries can be only made by the EJU Member Federations for each club. The entries included the complete list of the member of the teams and also the list of the results of the last national team championship. The entries have to be sent to the EJU General Secretariat (contact data: 37, Marina Court, Giuseppe Cali' street, Ta'Xbiex XBX 1421, Malta, Phones +356 21 310463, Fax +356 25401186, email [gs@eju.net](mailto:gs@eju.net)).

The entries are the official documents and no other changes/additions will be accepted without exception in any case. **Entries dead line is 31<sup>st</sup> of March 2010.**

In order to participate in a competition of the European Championships for Clubs, a judoka must be an authorised member of the club, according the rules of the federation the club is representing. During the year of running ECC, he cannot participate in an official contest for another club. In one ECC year, one judoka can compete in ECC just for one club. Each team is allowed to have any number of foreign judoka on the list of competitors who, however, have to fulfil the same conditions as authorised members of the club.



## **2. COMPETITION FORMULA**

The ECC is divided in Preliminaries (1<sup>s</sup> and 2<sup>nd</sup> round) and Final Part (3<sup>rd</sup> round and final).

The EJU member federations are divided in 3 areas and each area is divided in 2 regions:

### Preliminaries - 1<sup>st</sup> Round on 26<sup>th</sup> of June 2010

- Will be held in each of the 6 regions
- Organisers will be drawn at the European Championships in Vienna on 24<sup>th</sup> of April 2010.
- 1 tatami (for 2-3 teams) or 2 tatami (for 4 and more teams)
- If there are 7 teams or more than 7 teams, it will be possible to have 2 competitions, on 2 different places on the same day
- 4 referees, one of them will be also observer (paid by the organiser), for each tatami. Organisers have to cover the transport (flight tickets economy class or train tickets if necessary), accommodation (2 nights: 1 night before the competition and one after the competition), 3 meals each day, and 200 euro for each referee, for one competition as daily allowance.
- Teams of 5 competitors (-66kg, -73 kg, -81 kg, -90 kg and +90 kg)
- Pool system
- One match between 2 teams consists 2 rounds of 5 contests (the break between the 2 rounds will be 30 minutes)
- First 2 teams are going into preliminaries 2<sup>nd</sup> round

### Preliminaries - 2<sup>nd</sup> Round on 14<sup>th</sup> of August 2010

- Organisers will be drawn during the European Championships in Vienna on 24<sup>th</sup> of April 2010.
- 1 tatami (4 teams)
- 4 referees, one of them will be also observer (paid by the organiser). Organisers have to cover the transport (flight tickets economy class or train tickets if necessary), accommodation (2 nights: 1 night before the competition and one after the competition), 3 meals each day, and 200 euro for each referee, for one competition as dally allowance.
- Teams of 5 competitors (-66kg, -73 kg, -81 kg, -90 kg and +90 kg)
- Pool system
- One match between 2 teams consists 2 rounds of 5 contests (the break between the 2 rounds will be 30 minutes)
- First 2 teams are going into final part 3<sup>rd</sup> round



### Final Part 3<sup>rd</sup> Round (6 teams from the 2<sup>nd</sup> round + 3 medallists from previous year) on 25<sup>th</sup> of September 2010

- Will be held in 3 places by the silver and two bronze medallists of the previous year. If in one group the medallists from the previous year decline to organise the event, the other two teams can apply for the event and the EJU will decide about organiser.
- 1 tatami (3 teams)
- 4 referees, one of them will be also observer (paid by the organiser). Organisers have to cover the transport (flight tickets economy class or train tickets if necessary), accommodation (2 nights: 1 night before the competition and one after the competition), 3 meals each day, and 200 euro for each referee, for one competition as dally allowance.
- 1 EJU delegate (paid by the organiser). The organiser has to cover the accommodation and 3 meals/day. The EJU will cover the transport and daily allowance.
- Teams of 5 competitors (-66kg, -73 kg, -81 kg, -90 kg and +90 kg)
- Pool system
- One match between 2 teams consists 2 rounds of 5 contests (the break between the 2 rounds will be 30 minutes)
- First team is going into the final

### Final of ECC (3 winners of the 3<sup>rd</sup> round) on 6<sup>th</sup> of November 2010

- Organiser of the final 2010 is automatically the winner of the year 2009. The bid with signature of the organising club must be confirmed at latest on 29<sup>th</sup> of January 2010. In case of no signature, the club placed 2<sup>nd</sup>, eventually the 3<sup>rd</sup> of the last year will be invited to organise the final. The contract must be signed before the 28<sup>th</sup> February 2010.
- The EJU fee for organising the ECC final is 15.000 euro and has to be paid by 31<sup>st</sup> of March 2010 at latest.
- 1 tatami (4 teams)
- 4 referees (paid by the organiser). Organisers have to cover the transport (flight tickets economy class or train tickets if necessary), accommodation (2 nights: 1 night before the competition and one after the competition), 3 meals each day, and 200 euro for each referee, for one competition as dally allowance.
- 5 EJU delegates (paid by the organiser). The organiser has to cover the accommodation and 3 meals/day. The EJU will cover the transport and daily allowance.
- Teams of 5 competitors (-66kg, -73 kg, -81 kg, -90 kg and +90 kg)
- Two semi-finals and final
- One match between 2 teams consists 2 rounds of 5 contests (the break between the 2 rounds will be 30 minutes)
- Winner of semi-finals are meeting in the final, losers of the semi-finals are both bronze medallists
- 4 Awarding cups in different sizes are paid by EJU, as every year. The awarding cups are chosen out from the EJU Corporate Program
- 15 EJU Medals / each team (Gold, Silver and Bronze) must be ordered and paid by the organiser through the EJU – Marketing Program



### **3. ECC FEES FOR PARTICIPATION**

The EJU fee is 1500 EUR. Payment deadline is the 30<sup>th</sup> March 2010.

Notice: All bank fees and bank transfer costs are to be paid by the mandatory.

### **4. VENUE**

All clubs are organising ECC Men events have to ask by themselves the General Secretariat for a copy of the ECC guidelines.

### **5. ACCOMODATION AND TRANSPORT**

The organising clubs have to send the technical details (including information about accommodation, location, and detailed information about the program) to the EJU General Secretariat for confirmation, by not later than 6 weeks before the event. Once confirmed, the organiser has to send out these technical rules immediately after the confirmation through EJU. The participating teams have to inform the organiser about their transport schedule and accommodation requirements not later than 3 weeks before the event.

The organising clubs are responsible for the transfer between the closest international airport or the closest train station, the official hotel and the competition hall, for all the participating teams, referees and EJU Officials.

The organising clubs are requested to give a list of the accommodation possibilities to all participants at that event in three different price levels.

Every team has to cover own transport to the closest international airport or the closest train station (to competition place).

Every team has to cover the own accommodation, food and breakfast.

### **6. WEIGH-IN**

The official weigh-in must be organised on the evening before the event.

Unofficial weigh-in: 18:00h – 19:00h

Official weigh-in: 19:00h – 20:00h

The EJU referees are responsible for the control of the weigh-in.



## **7. DRAW**

The draw will be held at the European Championships in Vienna on 24<sup>th</sup> of April 2010  
There will be decided who is A, B, C, D, E, F.

Draw of the 3<sup>rd</sup> Round will be done by the EJU observer, in co-operation with the EJU referees. There will be 3 teams. The organiser will compete against A, then A will compete against B, and in the end the organiser will compete against B. The draw will decide who from the guests are A and B.

The three winners of the third round are qualified for the final, organised by the winner or one of the medallists of the year 2009.

## **8. REFEREEING**

Each contest of each category has to finish with a decision (if after the regular time is no decision, then Golden Score, then if still no decision hantei). No hikiwake. The winning team will be decided on the number of contests won.

All competitors accepted for the competition after the official bow on the mat, have to compete. If one competitor does not compete, the club, through its Federation, must pay a fine of 500 EUR.

A competitor, who has presented himself for the competition and does not compete, loses the right to compete for the whole day. The team can enter another fighter as replacement in the same weight category.

If one team does not arrive for a match after the draw, the other team will be declared the winner by 10-0 (100-0).

In the case that a team withdraws from the competition and has not informed the organiser and the EJU General Secretariat by written notice at least 1 month in advance, the club will pay the amount of € 1,000 to the EJU. In case such a notice is not received or is received less than 15 days in advance, the amount will be € 2,000. The amounts will be paid even if no costs are involved. No club can lay claim to any additional compensation whatsoever. In case of "force major", recognised by the EJU, the amount to be paid to the organiser can be reduced or waived.

## **9. TEAMS**

The team will consist of five (5) competitors in the following weight-categories: -66 kg, -73 kg, -81 kg, -90 kg and +90 kg. The competition will proceed in this order. Each competitor is authorised to fight in his category or the category immediately above.

One team consist of all competitors inscribed and the additional officials according to the EJU rules:

7 - 8 competitors	five officials
9 - 10 competitors -	six officials
11 - 12 competitors -	seven officials



13 - 14 competitors - eight officials  
15 - 16 competitors - nine officials

## **10. JUDOGI / BACK NUMBERS**

The teams must bring blue and white judogi. The advertising on the Judogi should be according to the ECC Judogi Advertising Regulations.

Official back numbers will be designed by the EJU Event Store for the ECC 2010. All individual competitors of each team are obliged to wear the official ECC back numbers on their judogi starting from Round 1.

Guidelines on ECC back numbers will be published 1 month before the draw and orders must arrive to EJU Event Store at latest 1 months before the Preliminaries – 1<sup>st</sup> Round.

## **11. DOPING CONTROL / MEDICAL ASSISTANCE**

The doping control will be carried during the final round of the European Championships for Clubs. One weight category is drawn. Every registered competitor of the team takes part to the draw lot. The Gold medal winner and another drawn medallist are tested. In the case of non-contestation of that weight category then the immediate superior weight category or immediate inferior of the same team will be tested (Two Tests for the Male).

Costs of samples taking and of laboratory analyzes are covered by organizer.

EJU doctor will be delegated to supervise the doping control.

Costs of the EJU doctor covered by organizer: accommodation 2 nights, 3 meals a day. EJU will cover his transport and daily allowance. Doctor will be one of the 5 EJU officials invited for the ECC final.

The organiser is obliged to organise medical staff and ambulance services for the complete duration of the competition.

## **12. PRIZES**

The winning team will receive the cup of the European Champions of Clubs 2010 and the following EJU prize money:

1 <sup>st</sup> place	10.000 EUR
2 <sup>nd</sup> place	5.000 EUR
3 <sup>rd</sup> place	2.500 EUR
3 <sup>rd</sup> place	2.500 EUR
