100 € per participating athlete of Non-EJU Member Federations.

EJU Participation Fee is to be paid on spot to an EJU representative.

5. Age

15 years old and over (Born in 2000 and before)

6. Responsibility of the Federations

The competitors will compete under the full responsibility of their federations. Each National Federation is responsible for insuring its judoka against 'injury and third part risk (public liability)' during the period of the camp. The European Judo Union and Belarusian Judo Federation decline all responsibility.

7. Facilities

Available for athletes: 1200 m² tatami, gym, saunas, places for leisure activities and other services.

8. Transport

Airport: Minsk International Airport (MSQ)

Distance from the Airport to official hotel: 35 km

Railway station: Minsk

The organizer will provide transfers between the Minsk International Airport/Minsk railway station and official hotel as well as between the Minsk Sports Palace and official hotel. Transportation will be offered only to those participants who are accommodated in the official hotel. Participating National Federations are responsible for their own travel to Minsk/Belarus.
