# 5. Participation

This European Open is open for all EJU / IJF Member Federations. **Per Federation a maximum of 4 competitors** per weight category can compete. The competitors must be of the same nationality as the National Federation, which enters them.

# 6. Categories & Duration of Contests

Male: -60 kg / -66 kg / -73 kg / -81 kg / -90 kg / -100 kg / +100 kgDuration: **5 minutes** Golden Score: No time limit

# 7. Entry Fee

The EJU entry fee of 10€ per athlete must be paid at registration.

# 8. Accreditation & Control of Nationality

At least one team official and maximum two must attend the accreditation on **Friday from 10:00 – 18:00** in order to confirm the delegation. Without this confirmation in time, a nation will not be put into draw and will not be allowed to compete. Each Head of Delegation must be present during the control of participants. Passports or photocopies of passports from all competitors must be available on request (national ID Card showing nationality and date of birth or a copy is also accepted). The competitors must not be present at the nationality control. An EJU accreditation card with a photograph will be issued to competitors and officials.

# 9. JUDOBASE Registration

All participants and delegates must be registered for this event in the IJF Registration System (**JUDOBASE**): <a href="https://admin.judobase.org/">https://admin.judobase.org/</a>.

Deadline for JUDOBASE Registration is Monday 5<sup>th</sup> October 2015.

After the deadline further registrations (late entries, replacements) are exclusively handled during accreditation according to the following rules:

- Persons without IJF ID Card can only be entered on spot, if IJF ID Card will be ordered until end of Accreditation.

# 11. Weigh-in

Official weigh-in for each weight category is held the evening before the competition day (see programme). **Athletes must present their EJU accreditation card and his/her passport** (National ID Cards showing nationality and date of birth are also accepted).

Official scales will be available for test weigh-in on Friday from 08:00 – 22:00 (except during official weigh-in from 19:00-19:30). The test scales will be available at the Crowne Plaza, Glasgow.

Random weight checks with the same rules as the official weigh-in can be organised before the first contests in the morning of the competition. The weight of the athlete cannot be more than 5% higher (without Judogi) than the official maximum weight limit of the category.

# 12. Competition Mode

Competition system: Elimination (KO) system with the quarterfinal (last 8) repechage. The competition will be carried out according to the rules and sporting codes of the IJF and EJU.

#### 13. Draw

The draw will take place on **Friday 9 October at 20:00hrs at the official hotel Crowne Plaza, Glasgow**. Each National Federation must send at least one (1) delegate to attend the draw. A maximum of two (2) delegates per National Federation will be authorised.

The top eight (8) from the entered competitors in each weight category will be seeded according to the current IJF World Ranking List.

Dress code: Jacket suit with tie.

# 14. Refereeing

Only referees with IJF license A or B and valid classification A or B can be entered. Each federation may enter one (1) referee, the organising federation may enter a maximum of four (4) referees with the same requirement as aforesaid.

The referee meeting will be held on **Friday**, **19:00** hrs at the official hotel Crowne Plaza, **Glasgow**. For all referees the attendance at the referee meeting is strictly compulsory.

Dress code: Jacket suit with tie.

# 15. Coaching

All coaches must fully adhere to the Code of Conduct for Judo Coaches.

Dress Code Draw: Jacket suit and tie

Elimination rounds: National track suit with trousers reaching down to

shoes or jacket suit with tie

# 16. Judogi Control

#### **Approved Judogi**

All Judoka must compete in IJF Approved Judogi (see <a href="www.ijf.org">www.ijf.org</a> ). The following EJU suppliers offer IJF approved judogi: ADIDAS, GREEN HILL, SFJAM NORIS, HIKU (BUDO SPORT AG)

#### Judogi Control

It will be operated with a Sokuteiki prior to the fight. Judogi must have an IJF Official Label "APPROVED JUDOGI" with an optical code which cannot be falsified. The label will be controlled with an optical lamp. Each of the competition clothing articles (jacket, trousers and belt) must have an IJF official label.

#### **Backnumber**

Each competitor taking part in the EJU events is obliged to have sewn on the back of his Judogi the official backnumber (both EJU and IJF are allowed) bearing his surname and his National Olympic Committee abbreviation. The backnumber can be ordered from <a href="https://www.mybacknumber.com">www.mybacknumber.com</a> or <a href="https://www.ijfbacknumber.com">www.ijfbacknumber.com</a> (Attention: production and delivery may take around 4 weeks). The SPONSOR part (if needed) will be given to the head of delegation during registration, and the athletes can stick it themselves using the special glue on the back number.

#### **Markings and Advertising**

The space on the **shoulder stripes** (25cm x 5 cm on both right and left side) can be either used for EJU Master and Top Suppliers (currently ADIDAS, GREEN HILL and SFJAM NORIS) or for own sponsors of the Federation or Judoka, **BUT not for any other Judogi supplier**.

The space on the *upper arms* (10cm x 10cm on both right and left side) can be used by federations and their Judoka as usual for their own benefit.

The space on the *right chest* (5cm x 10cm) can be used by federations and their Judoka for their own sponsors. The logo of a Judogi brand can only be used, if it corresponds with brand of the Judogi itself and if it is of an EJU Master or Top Supplier (currently ADIDAS, GREEN HILL and SFJAM NORIS).

**Please note**: On all advertising spaces it is strictly prohibited to promote tobacco, alcohol, any substances listed in the doping code, or any product or service contrary to public morals. The space on the *left chest* ( $10 \text{cm} \times 10 \text{cm}$ ) can be used for the national colours or the national emblem corresponding with the IOC code on the backnumber (regional emblems are not allowed). In European Club Championships the club logo can be used instead of the national emblem.

All other markings on the Judogi, like Judogi brand logos, name of Judoka, etc. have to comply with the IJF Judogi Rules.

#### **Important:**

- If an athlete does not respect the Judogi rules, the athlete will not be permitted to pass
  the Judogi Control, and the coach who is responsible for the athlete will be suspended for
  the rest of the competition day.
- The organiser is not obliged to provide reserve Judogi at Judogi Control, but the athlete is allowed to present himself in another IJF Approved Judogi, complying with the Sokuteiki rule (and without backnumber) in this case no coach can go with this athlete to the mat!
- In the case of a repeated offence the coach will be suspended for the rest of the competition.

# 17. Transport

The Organiser will provide transfers between entry into the UK as above and official hotel and between the official hotel and competition venue. Transportation will be offered only to those participants who are accommodated via the organiser.



**Campanile guests please note:** Athletes and Team staff accommodated at the Campanile will be offered free transport to and from the competition venue. The pickup and drop of point for this transport will be at the Crowne Plaza hotel which is a 6 minute walk from the Campanile. They will also need to register, weigh-in, and attend the draw at the Crowne Plaza.



Lunch is available for purchase by the teams at the Emirates Arena restaurant.

All participants to be accredited should stay at the official hotel. Reservations at the official hotel have to be booked exclusively through the Organiser on a first come – first serve base.

#### Hotel reservation deadline: Friday, 18 September 2015

Rooms are limited in the official hotel so early booking is highly recommended.

Possible reservations of extra rooms after the hotel reservation deadline will be surcharged with an additional 10%. NO exceptions will be made.

# Delegates not accommodated via the organiser have to pay an accreditation fee of €100 per person.

All federations must send their full requirements, accommodation and transport, by email to <a href="mailto:judo@cseplc.com">judo@cseplc.com</a>. CSE will then produce a pro forma invoice and send this with bank details to the federation so payment can be made. All federation must confirm their requirements with CSE by **Friday 18 September 2015**. Reservations at the official hotels have to be booked exclusively through the organiser, CSE on behalf of British Judo, otherwise the accreditation fee will be applied.

On arrival, guests staying at the Crowne Plaza for this event must check-in at the judo accredation room, not the hotel's reception.

Please note: Entry for the competition must also be made via the IJF Judobase System. Entry and accommodation booking are two different booking tools.

Countries which cannot make bank transfers are entitled to pay in cash money upon arrival without any surcharge, if they inform the organiser and specify the number of participants before the hotel reservation deadline.

#### **Cancellations**

Up to 30 days before arrival: no charge 29 – 15 days before arrival: 50% refund Less than 15 days: no refund

Important: Injuries, visa problems or sickness are not valid reasons for cancellation of rooms.

In case of any damage to hotel property or competition venue caused by members of a delegation, their national federation will be charged by the organising committee.

# 19. Payment

#### **Accommodation**

All accommodation payments are to be made to CSE. Once your booking is made via email with CSE, they will email an invoice which is to be paid immediately.

NO ACCOMMODATION PAYMENTS are to be made directly to the British Judo Association, EJU or the hotel. Please do not pay any money directly with any organisation apart from CSE.

All payments must be made to CSE, as above by Friday 18 September 2015.

All fees MUST be paid before the athlete is given their accommodation keys, accreditation and will not be included in the draw until the fees have been received by the hosts.

All bank fees and money transfer costs must be paid by the sender federation.

#### **Entry Fees**

Entry fee (10 euros) are to be made at registration on Friday 9 October 2015.

# 20. Responsibility of Federations

The competitors will compete under the full responsibility of their federations. Each national federation is responsible for insuring its competitors against "injury and third part risk (public liability)" during the period of the tournament. The European Judo Union and the organiser decline all responsibility.

# 21. Anti-Doping
