3. Participation

EJU / IJF Member Federations can participate at the OTC.

4. EJU Participation Fee

30 $\mathbf{\varepsilon}$ per participating athlete of EJU Member Federations.

100 € per participating athlete of Non-EJU Member Federations.

EJU Participation Fee is to be paid on spot to an EJU representative.

5. Age

15 years old and over (Born in 2002 and before)

6. Responsibility of the Federations

The competitors will compete under the full responsibility of their federations. Each National Federation is responsible for insuring its judoka against 'injury and third part risk (public liability)' during the period of the camp. The European Judo Union and Belarusian Judo Federation decline all responsibility.

7. Facilities

Available for athletes: 1200 m² tatami, gym, saunas, places for leisure activities and other services.

8. Transport

Airport: Minsk International Airport (MSQ)

Distance from the Airport to official hotel: 35 km

Railway station: Minsk Pasažyrski

The organizer will provide transfers between the Minsk International Airport/Minsk Pasažyrski railway station and official hotel. Transportation will be offered only to those participants who are accommodated in the official hotel. Participating National Federations are responsible for their own travel to Minsk/Belarus.

13. Visa

For nations who need VISA to enter Belarus, please send the "Visa Application Form" fully filled not later than **July 7, 2017**.

Please note!

In order to obtain a visa and cross the state border of the Republic of Belarus foreign citizen must have a certificate of insurance of a foreign country, satisfying the appropriate specific requirements, or take out health insurance at border checkpoints.

Foreign citizens are required to have a compulsory health insurance policy (from Belarusian insurance companies Belgosstrakh and Beleximgarant) or medical insurance policy took out in a foreign insurance organization.

Health insurance should meet the following requirements.

- contain the name of a foreign insurance company, its location, phone numbers, as well as the surname, first name, patronym (if any) of the foreign citizen;
- distribute its effect on the territory of the Republic of Belarus;
- be valid for a period of temporary stay in the Republic of Belarus;
- the insured amount should be not less than 10,000 euros.

Please note! According to the Resolution of the Council of Ministers Nº1044 of 19 December 2016 participants in European Judo Open W&M Minsk 2017 and/or EJU OTC «Going for gold» Minsk 2017 are exempted from consular fees for granting Belarusian visas for a period of above mentioned events.

Peculiarities of issuance of entry visas at the «National Airport Minsk».

At the National Airport «Minsk» the entry visa requests are processed by the Division for the Admission of Foreigners of the Consular Department of the Ministry of Foreign Affairs (DAF).

Foreign citizens arriving with flights from Russian Federation **can not** obtain entry visas of the Republic of Belarus in DAF at the Airport. Foreign citizens arriving with flights from Russian Federation must address for visas diplomatic representations and consular institutions of the Republic of Belarus in their own countries.
