
### **Backnumbers**

Each competitor taking part in the EJU events is obliged to have on the back of his Judogi the **official 2011 EJU / IJF back number.** The 2010 EJU / IJF back number will only be accepted until 31<sup>st</sup> December 2011.

Sizes: Each athlete is responsible for his judogi to comply with the IJF Sokuteiki

The participating athlete / federation is responsible for ordering and sewing of the the back number, which must be the official EJU / IJF one. It should be ordered from <a href="https://www.mybacknumber.com">www.mybacknumber.com</a>. Production and delivery takes around 4 weeks.

The SPONSOR part (if needed) will be given to the head of delegation during registration, and the athletes must stick it themselves using the special glue on the back number. In case the participating federation sends fewer athletes than registered **in the numerical inscription**, the federation will be charged the cost of the back number of all cancelled athletes.



## **Entry Fee:**

According to the EJU requirements, each competitor at the EJU World Cup Tournament is obliged to pay the **EJU fee of EUR 10** to the EJU. This amount must be paid by the National Federations for each their competitor. The payment is accepted by the EJU official upon accreditation or to be transferred <u>till 20</u>, <u>September</u> to the following account:
